Chairman Allison A. Jones called the meeting to order at 10:08 a.m. and asked for roll call. A quorum was established.

1. Call to order, roll call and introduction of guests
2. **Approval of the minutes.** A motion was made by Commissioner Allison Jones, and a second by Commissioner Lisa Woodruff-White to approve the minutes of the May 9, 2007 Legal Committee meeting. The minutes were approved.
3. **Update on Katrina Cottages Cooperative Endeavor Agreement and FEMA AHPP Agreement.** A copy of the Development Services Agreement was provided for all members. Keith Cunningham gave an overview of that document with discussion following. After a lengthy discussion of the issues involved, Commissioner John Kennedy requested information for the board regarding the name of the Cypress Group, principles, guaranty from the principles of the Cypress Group for the complete construction contracted amount, a surety bond supplied by Cypress Group for Katrina Cottage Project and the last audited financial statements for Cypress Group. Commissioner Kennedy also inquired as to why the Jackson Barracks site was selected and who the owners are of the sites previously selected as part of the Katrina cottages Proposal. A recommendation by Commissioner Allison Jones was made to defer this issue to the full board meeting. There was a second by Commissioner Wayne Woods.
4. **Update on Ninth Ward Housing Development Corporation Litigation.** Wendell Clark, Long Law Firm provided an updated status report on this litigation so that the committee could revisit the LHFA's position, and matters involving the subject properties. Upon a motion by Allison Jones the committee went into Executive Session.
3. **Update on Agency Trust Funds.** The committee received an overview of the Fund. Other than the blessing of the legal committee, no other action is required except that the board will make recommendations on how the money is spent.
4. **Defaulted 202 Properties.** The committee went into Executive Session.
5. **Other Business.** No other business to discuss.
