LHFA, as joint mortgage holder with HUD, sued property owner (202 property) for failure to file and collect on all property insurance claims after Hurricane Katrina to protect mortgage interests; failure to pay all mortgage payments due; failure to properly manage property. Law suit was filed to interrupt prescription because property owner and insurer were not cooperating.

Cooperation since the suit has been better, so we have held the suits in abeyance pending efforts by the property owner to refinance the property. We have received more information from the property owner and insurer, and have been working with LHFA staff (Ms. Bratkowski and Ms. Wallace, primarily), to determine whether insurance claims have been proceeded and funds allocated properly. Several other 202 properties, on which suit was also filed, have been refinanced.

Plaintiff participated in Tri-Delta Program. Due to failures of contractor in original program, LHFA hired new contractor (Ron Hutson) to complete program rehabilitation efforts. Hutson's work was completed in September, 2006. House was largely destroyed by fire in March, 2007. Plaintiff asserts that work done under program was not properly done, so has sued contractor, local Police Jury, LHFA and its program consultant. LHFA has answered suit for Agency and Helene Brown. The Agency hired fire reconstruction and electrical engineering experts early on, who have determined the cause of fire was unrelated to rehab work. Outside counsel foresees favorable probability for successful defense.

This matter involves a suit against Willowbrook Apartments, a property owned by the Agency in New Orleans, La. and previously managed by Barron Builders. The suit was filed in 2005 by

Phelps Dunbar, initiated foreclosure proceedings against Caleb Community Development Corporation (“Caleb”) on behalf of the LHFA. Caleb executed a promissory note in favor of the Agency in the amount of \$1,941,030.00, which was secured by an act of mortgage on nine (9) pieces of property encompassing what has turned into the Capital City South Project. This project was a joint endeavor between the Agency and Caleb in which Caleb was to remodel and convert existing uninhabited housing into affordable low-income housing for area residents. Caleb defaulted on the loan which, pursuant to the act of mortgage and the promissory note, allowed the Agency to initiate foreclosure proceedings. A petition for executory process was filed on June 10, 2008 on behalf of the Agency and a writ of seizure and sale was issued by the sheriff’s department on June 16, 2008. This matter was scheduled for sheriff’s sale on August 28, 2008. Original sheriff’s sale was passed, and subsequent hurricanes caused further delay.

Additional issues have arisen regarding errors in the closing documents and property description contained therein. The sale has been passed at this time and has not been rescheduled pending resolution of those issues.

Nathan Lee v. Catherine Hatfield

Catherine Hatfield participated in our Home Program and received \$22,860.49 on 12/14/94. The mortgaged property was a home in Myrtle Grove Subdivision having the municipal address 3109 Myrtle Grove Drive Baton Rouge, La 70810. Catherine Hatfield sold the property on May 1, 2002 for a sales price of \$105,000.00, to a Nathan Lee. The Home mortgage was not paid off at the time of sale.

On August 24, 2005, the Agency was contacted by a title attorney, and notified that Nathan Lee was attempting to sale the property to some unknown third party. A request was made around that time for the Agency to forgive the loan. The request was denied, and the Agency began collection attempts on Nathan Lee. Litigation resulted wherein Nathan Lee, filed suit against Catherine Hatfield. The Agency entered as a third party.

AAMAGIN Property, LLC v LHFA

A lawsuit was filed by Aamagin Property LLC (“Aamagin”) against the LHFA alleging that the Agency had violated Aamagin’s constitutional rights to due process in violation of the United States Constitution and the Louisiana State Constitution. In essence, Aamagin Property LLC sought to take part in a program initiated by the Agency wherein Aamagin was issued a certain amount of federal low-income housing tax credits. Plaintiff failed to meet specific requirements for an individual and/or corporation to take part in the program; accordingly, their application was denied by the Board of Commissioners of the Agency. The low-income housing tax credits issued to Aamagin were recaptured by the Agency and were set to be distributed to other qualified individuals and/or corporations. Aamagin filed an injunction requesting relief. The Agency took subsequent action to quell the object of Aamagin’s complaint and thereafter a resolution was reached wherein the plaintiff agreed to dismiss his claim against the Agency, without prejudice.

The Agency’s legal department continues to monitor suits throughout the state resulting from our Single Family second mortgages program. Though the Agency is not directly named, we screen those actions to protect the Agency’s interest in those second mortgages.
