Call to order, roll call and introduction of guests. Commissioner Tyrone A. Wilson called the meeting to order at 11:30 a.m. and asked for roll call. At first there was not a quorum of regular committee members. Commissioner Michael L. Airhart then began a discussion about the establishment of a quorum and who can vote in committee, in which Commissioner Wilson, Commissioner Airhart, Commissioner Donald B. Vallee and General Counsel Terri Ricks participated. During the discussion, there was some question as to whether the minutes from December needed to be amended, given the information provided. Commissioner Airhart stated he wanted the record to reflect that

notwithstanding what the lawyers said, it was his opinion that the “Board Contact Resolution” did not get out of committee favorably in December because the Chair voted on the resolution. On the question as to whether the December minutes were correct, Commissioner Thaxton clarified that the procedure may have been flawed, but the minutes were correct. Commissioner Wilson stated that the procedure was not flawed in his opinion as the matter had been handled in the tradition of the Committees in the past couple of years. During the discussion, Commissioner Guy T. Williams entered in and a quorum of regular commissioners was established. Commissioner Wilson then pulled the discussion back to the agenda.

Approval of the minutes. A motion was made by Commissioner Wilson, with a second by Commissioner Williams, to approve the minutes of the December 8, 2010 committee meeting. The minutes were approved unanimously.

Discussion and Decision on Timeline for evaluations of Vice-President and President. Commissioner Wilson proposed that the Vice-President and President should be evaluated using the same process and document as last year and that the proposed timeline of February to be the deadline for commissioners’ evaluations to be returned to him in order to present the compiled evaluations to the full board in March 2011, and presented to the President and Vice-president after the March meeting.

There was further discussion of the matter. Commissioner Donald Vallee and Commissioner Michael Airhart discussed using outside customers as a gauge for the agency’s effectiveness and service delivery for the evaluation of the President and Vice-President. Commissioner Adena Boris stated she did not agree that agency stakeholders should be involved in evaluating the performance of the President and the Vice President.

Commissioner Williams stated he was not in favor of outside groups involved in the evaluation process. Commissioner Thaxton stated there was a question as to how to evaluate what third parties think to properly use the proposed form.

After further discussion, Commissioner Williams moved that the board proceed forward on the evaluation process using the timelines proposed by the Chair and the process utilized last year. Commissioner Boris seconded the motion. The motion passed unanimously.

Other Business. No other business was presented before the Committee.

1. Adjournment. The committee adjourned by Commissioner Wilson, to which there was no objection. Committee adjourned at 12:01.

The following resolution was offered by Commissioner _____ and approved by Commissioner _____:

RESOLUTION

To adopt the Staffing Plan for the Fiscal Year Ending June 30, 2012 (Exhibit A, entitled “LHFA Staffing Plan FY 2011/2012”) and other related matters.

WHEREAS, the Louisiana Housing Finance Agency (the “Agency”), as authorized by the State of Louisiana, shall establish its own staffing plan:

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Louisiana Housing Finance Agency (the “Board”), acting as the governing authority of said Agency:

SECTION 1. The Agency adopts the Staffing Plan for the Fiscal Year Ending June 30, 2012 (Exhibit A, entitled “LHFA Staffing Plan FY 2011/2012”).

SECTION 2. The Agency President, is hereby delegated the powers of appointing authority as such are contemplated by the Rules of the State Civil Service Commission, such that he or she has full power and authority to manage all employees of the Agency, with the exception of the Vice-President, which power includes the authority to hire, promote, reassign, and discipline the employees of the Agency.

SECTION 3. In the temporary absence of the Agency President or whenever there is a vacancy in the office of the Agency President, the Agency Vice-President is hereby delegated the powers of appointing authority as such are contemplated by the Rules of the State Civil Service Commission, such that he or she has full power and

authority to manage all employees of the Agency, which power includes the authority to hire, promote, reassign, and discipline the employees of the Agency.

SECTION 4. In the temporary absence of the Agency Vice-President, the Agency President or Vice-President is hereby authorized to delegate his or her powers of appointing authority via authentic act to a member of the Agency's executive management team as contemplated by the Rules of the State Civil Service Commission, such that the delegatee has full power and authority to manage all employees of the Agency, which power includes the authority to hire, promote, reassign, and discipline the employees of the Agency, as authorized by the Civil Service Rules.

SECTION 5. The appointing authority is hereby granted the power and authority to transfer any position within the table of permanent organization within the total positions and pay scales consistent with Exhibit A. The appointing authority may add restricted appointments, job appointments, and student positions (non-permanent positions) as necessary to meet the needs of the Agency within the budgeted authority for salaries and benefits.

SECTION 6. The Chairman of the Agency Board of Commissioners is hereby directed to execute an authentic act evidencing this delegation of appointing authority status to the Agency President in his or her capacity as President of the Agency or to the Vice President, in the absence of the President, in his or her capacity as the Vice President of the Agency.

SECTION 7. The Chairman, Vice Chairman, President, Vice President, and/or Secretary of the Agency are hereby authorized, empowered, and directed to execute any

forms and/or documents required to be executed on behalf of and in the name of the Agency the terms of which are to be consistent with the provisions of this resolution.
