State law (LSA R.S. 24:513(D)(4)) directs the Louisiana Legislative Auditor to conduct performance audits, program evaluations, and other studies to enable the legislature and its committees to evaluate the efficiency, effectiveness, and operations of state programs and activities. In accordance with these legislative mandates, we have scheduled a performance audit on affordable housing programs in Louisiana, which includes the Louisiana Housing Corporation.

While my staff has not yet developed specific audit objectives, we would like to schedule an entrance conference to discuss various issues related to the audit.
