RESOLUTION

Resolution extending the previously (July 10, 2024 and August 14, 2024) adopted Short-Term LHC Operating Budget in the amount of \$11.5M for the additional period of October 01, 2024 – November 01, 2024, as related to the LHC Operating Budget for the Fiscal Year Ending June 30, 2025; and providing for other matters in connection therewith.

WHEREAS, the Louisiana Housing Corporation (“LHC” or Corporation”) was created by and pursuant to the Louisiana Housing Corporation Act contained in Chapter 3-G of the Louisiana Revised Statutes of 1950, as amended (R.S. 40:600.86 through R.S. 40:600.111); and

WHEREAS, the LHC, as authorized by the State of Louisiana, shall establish its own operating budget.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors (the “Board”) of the Louisiana Housing Corporation, acting as the governing authority of said Corporation, that:

SECTION 1. On July 10, 2024, and extended on August 14, 2024, the Louisiana Housing Corporation adopted a Short-Term Operating Budget in the amount \$11.5M for the period of July 01, 2024 – October 01, 2024, as related to the Fiscal Year Ending June 30, 2025.

SECTION 2. The LHC staff and counsel are authorized and directed to prepare such documents and agreements as may be necessary to implement the Louisiana Housing

Corporation Fiscal Year 2025 Short-Term LHC Operating Budget in the amount of \$11.5 **extended** for an additional period of October 01, 2024 – November 01, 2024, as related to the Fiscal Year Ending June 30, 2025 Operating Budget.

SECTION 3. The LHC is hereby authorized, empowered, and directed the ability as may be necessary to create, change, amend, and revise any existing documents and/or commitments to the Louisiana Housing Corporation Fiscal Year Ending June 30, 2025 Operating Budget, the terms of which are to be consistent with the provisions of this resolution.

SECTION 4. The Chairman, Vice-Chairman, Executive Director, and/or Secretary of the LHC are hereby authorized, empowered, and directed to execute any forms and/or documents required to be executed on behalf of and in the name of the LHC, the terms of which are to be consistent with the provisions of this resolution.
