The meeting of the Single Family Committee was called to order by Ms. Danette O'Neal, Chairperson, on April 18, 2007 at 9:15 a.m. in the Committee Room 2 at Louisiana Housing Finance Agency, located at 2415 Quail Drive, Baton Rouge, LA.

The approval of the March 21, 2007 Single Family Committee Meeting Minutes were motioned by Commissioner Austin and seconded by Alice Washington.

Updates on the 2007A, 2006D, 2006C, 2006BR, 2006B, 2006AR, and 2006A Bond Issues, Loans by Lender, Loans by Parish and Whole Loan Report were given by Morise Duffin.

Commissioner O'Neal entertained a motion approving and authorizing the issuance of not exceeding One Hundred Million Dollars (\$100,000,000) of LHFA Single Family Mortgage Revenue Bonds, Series 2007B. On motion by Commissioner Austin and seconded by Commissioner Gachassin the following was approved:

RESOLVED: A resolution approving and authorizing the issuance of not exceeding One Hundred Million Dollars (\$100,000,000) of Louisiana Housing Finance Agency Single Family Mortgage Revenue Bonds, Series 2007B in one or more subseries (the "Series 2007B Bonds"); approving the form of the Twenty-Eighth Series Supplemental Indenture; requesting the State Bond Commission to approve the delivery of a subseries of such 2007B Bonds as Series 2007B-1 Bonds to be designated by the State Bond Commission as GO Zone Bonds; and providing for other matters in connection therewith.

Commissioner O'Neal entertained a motion approving the delivery of not exceeding Fifty Million Dollars (\$50,000,000) of LHFA Single Family Mortgage Revenue Bonds, Series 2007B-1, as GO Zone Bonds. On motion by Commissioner Gachassin and seconded by Commissioner Austin the following was approved:

RESOLVED: A resolution approving the delivery of not exceeding Fifty Million Dollars (\$50,000,000) of Louisiana Housing Finance Agency Single Family Mortgage Revenue Bonds, Series 2007B-1, as GO Zone Bonds (the “Series 2007B-1 Bonds” or “GO Zone Bonds”) to finance mortgage loans for home buyers located in the GO Zone; requesting the State Bond Commission to approve the delivery of such Series 2007B-1 Bonds as GO Zone Bonds; and providing for other matters in connection therewith.

There was a brief bond presentation given by Larry Englande of George K. Baum & Company. The presentation gave the basics of a Single Family Mortgage Revenue Bond Program. The process of the programs and bond structure decisions were explained. An overview of the program in which the Issuer’s Staff / Administration duties and Master Servicer’s Duties and how the reporting is done was explained.

Other Business

There was no further business to come before the Committee. The meeting was motioned to be adjourned by Commissioner Gachassin and seconded by Commissioner Austin at 10:05 a.m.
